HISTORIC RESOURCES COMMISSION Wednesday, January 14, 2015

The Historic Resources Commission held a called meeting on Wednesday January 14, 2015 at 5:30 p.m. in the Council Chambers of the Graham Municipal Building. Commission Members present were Helen Sharpe, Brenda Sykes, Larry Brooks, Lauren Nance, and Denise Baker. Members absent were Grace Baldwin and Cary Worthy. Staff members present were Melissa Guilbeau, City Planner and Martha Johnson, Zoning/Inspections Technician.

Chair Larry Brooks called the meeting to order and explained the function of the Commission.

1. A motion was made to approve the minutes from the October 22, 2014 by Helen Sharpe, second by Brenda Sykes. All voted aye.

2. Elect Chair and Vice-Chair for 2015. Brenda Sykes made a motion to re-elect Larry Brooks as Chair and Helen Sharpe made a motion to re-elect Cary Worthy as Vice-Chair. All voted in favor.

3. Discuss and adopt Historic Resources Handbook. Larry Brooks said an excellent job was done by Melissa Guilbeau. There was a lot of good information and was very interesting along with good pictures. Ms. Guilbeau stated the handbook had been worked on since 2006 and she put finishing touches on it. Denise Baker made a motion to adopt the handbook, second by Brenda Sykes. All voted aye.

4. Set regular meeting date. Ms. Guilbeau said by the ordinance you must meet at least once a quarter. She would recommend meeting quarterly in January, April, July and October, keeping in mind meeting late September or early October for the Façade Grant applications. If you have a called meeting in the other months for COA Ms. Guilbeau recommended keeping it the same day and time as the scheduled meetings. After much discussion among the Board, the consensus was to set a regular meeting date of quarterly on the second Tuesday of the month at 6:00pm for January, April, July and October. Meetings during the other months will be called as needed but still on the second Tuesday at 6pm. Brenda Sykes made a motion to accept this decision, second by Lauren Nance, all voted aye.

5. Discuss annual report to City Council to be presented on March 3rd. The report shall include a comprehensive and detailed review of the activities, problems and actions of the Commission, as well as any budget requests and/or recommendations. Ms. Guilbeau suggested presenting the 2014 COA applications and decisions, the 2014-2015 Façade Grant program, and changes to the ordinance in 2014. Also the Historic Resources Handbook, the proposed N Main Street local Historic District, budget needs and any other items needing to be addressed. Ms. Guilbeau said she thought it would be nice if one or more of the Commission could present it. Ms. Guilbeau said she can work up the presentation for them to present. Mr. Brooks said he would volunteer to present it if no one else did.

Helen Sharpe mentioned the previous conversation the Commission had concerning funds she thought was to hire a consultant firm. Ms. Guilbeau said the funds would be needed to hire the consultant if the Board made the North Main Street District bigger they would need to establish the significance of that area. Ms. Guilbeau said she would work on the presentation and if anyone had any comments to email them to her.

6. Discuss upcoming North Main Street Historic District Resident's Meeting set for January 27th at 7pm at the Providence Church fellowship hall. Ms. Guilbeau asked the Commission to review the letter she drafted. Ms. Guilbeau said she will be mailing the letter this week to all property owners within the proposed district. Ms. Guilbeau said staff will be at the meeting to present information and answer questions and give out some handouts. Ms. Guilbeau said it would be good if some of the Commission members could attend the meeting.

Mr. Brooks mentioned to the Commission that Ms. Guilbeau will be leaving the City of Graham moving to Louisiana the first of February. Mr. Brooks stated the Commission does appreciate all the work she has done and all the updating she has completed. Mr. Brooks also said she had done a great job and will be missed.

With no further business the meeting was adjourned.



Potential designation of the North Main Street area as a Local Historic District

The North Main Street Historic District has been listed on the National Register of Historic Places since 1999. The map below shows the boundaries of this district, outlined in red.

The City of Graham's Historic Resources Commission is exploring the possibility of designating this area as a <u>local historic district</u>, which is different from being listed on the National Register. This would mean that alterations to the exteriors of all properties in the district would need to get a Certificate of Appropriateness before they could be permitted. This provides protection for all properties in the district by ensuring there will be no physical changes that are inconsistent with the historic character of the district.



This informational meeting is a **first step** in looking to designate this area as a local historic district. Next steps would include:

- City staff would prepare an investigation and report describing the significance of the district using material from the 1999 National Register designation. This would be forwarded to the State Historic Preservation Office for their comments.
- City staff would prepare a draft text amendment to the Development Ordinance, which regulates the development of land in the City and its extraterritorial jurisdiction. This text amendment would be the regulations that would govern the local historic district.
- City staff would prepare a draft set of standards and guidelines for review of Certificates of Appropriateness using material from the 1999 National Register designation.
- The proposal would be considered by the Historic Resources Commission at one of their regular public meetings. The HRC would make a recommendation to the Planning Board.
- The proposed text amendment would be considered by the Planning Board at one of their regular public meetings. The Planning Board would make a recommendation to the City Council.
- The proposed text amendment would be considered by the City Council at one of their regular public meetings. All owners of property in the proposed district will receive a letter in the mail notifying them of the public hearing. The public hearing will also be advertised in the newspaper. The City Council will make a decision on the text amendment. If adopted, the North Main Street area will be designated as a local historic district.
- The Historic Resources Handbook would be updated to include the standards and guidelines for review of Certificates of Appropriateness.

Will this affect my property taxes and/or value? Will I be required to make repairs or upgrades to my property? No, you will not be required to do anything. But when you decide that you want to make repairs or other changes to the exterior of your property, then before you would make those changes, you may need to get a Certificate of Appropriateness. How will this affect if I need or want to make repairs or changes to the exterior of your property? Before you make any changes to the exterior of your property, you may need to get a Certificate of Appropriateness (COA). The Property Owner's Manual of Graham's Historic Resources Handbook provides information on	how and when to apply for a COA. Is there any program to help me if the cost of doing "historic" repairs/upgrades is more than the cost of "regular" properties located in the Courthouse Square Historic District. This program may be expanded to include the North Main Street area if	it becomes a local historic district. The State Historic Preservation Office may be able to provide more information about other programs. What kind of standards will my exterior repairs/upgrades be held to? For example, will I still be able to afford to replace my windows with more energy-efficient ones? Part of the	process of designating the area as a local historic district will be to decide what characteristics contribute to its historic character. Standards or guidelines for types of materials and other building components will be agreed upon as part of the designation process. As an example of the types of standards, Graham's Historic Resources Handbook includes a Courthouse Square Historic District Manual which includes the standards and guidelines for that local historic district.
