The purpose of this addendum is to provide an updated bid worksheet and to upgrade and install new light fixtures, lamps, ballasts, Exit signs, and motion sensors in 11 buildings throughout the City of Graham, Town of Elon, and Town of Haw River, NC.

Points of Clarification and Summary of Amended Items

- 1. Lamp colors should match existing or to be coordinated between building owner and winning contractor.
- 2. All new ballasts should be low power. All Magnetic ballasts should be replaced with electronic ballasts.
- 3. Clarified that Occupancy Sensors should be Dual-Technology Occupancy Sensors. See amended Note (3).
- 4. Removed replacement of 10 (Qty) T8 8' fixtures from Graham Police Department.
- 5. A retrofitting option has been added to the bottom of bid worksheet. Retrofitting may be allowed at owner's discretion if existing fixtures are in good condition. Complete original bid worksheet assuming an entire fixture change-out. Use retrofit worksheet to include pricing to retrofit existing fixtures. Please complete both.
- 6. The reduced fixture count in the Graham Recreation Building is correct. The new fixture count assumes a new lighting configuration consistent with IESNA standards. Exact configuration will be coordinated by winning contractor.
