NC General Statue

Article 15. Streets, Traffic and Parking.

§ 160A-296. Establishment and control of streets; center and edge lines. (a) A city shall have general authority and control over all public streets, sidewalks, alleys, bridges, and other ways of public passage within its corporate limits except to the extent that authority and control over certain streets and bridges is vested in the Board of Transportation. General authority and control includes but is not limited to all of the following:

- (4) The power to close any street or alley either permanently or temporarily.
- (5) The power to regulate the use of the public streets, sidewalks, alleys, and bridges.

§ 20-174. Crossing at other than crosswalks; walking along highway. (a) Every pedestrian crossing a roadway at any point other than within a marked crosswalk or within an unmarked crosswalk at an intersection shall yield the right-of-way to all vehicles upon the roadway. (b) Any pedestrian crossing a roadway at a point where a pedestrian tunnel or overhead pedestrian crossing has been provided shall yield the right-of-way to all vehicles upon the roadway. (c) Between adjacent intersections at which traffic-control signals are in operation pedestrians shall not cross at any place except in a marked crosswalk. (d) Where sidewalks are provided, it shall be unlawful for any pedestrian to walk along and upon an adjacent roadway. Where sidewalks are not provided, any pedestrian walking along and upon a highway shall, when practicable, walk only on the extreme left of the roadway or its shoulder facing traffic which may approach from the opposite direction. Such pedestrian shall yield the right-of-way to approaching traffic. (e) Notwithstanding the provisions of this section, every driver of a vehicle shall exercise due care to avoid colliding with any pedestrian upon any roadway, and shall give warning by sounding the horn when necessary, and shall exercise proper precaution upon observing any child or any confused or incapacitated person upon a roadway. (1937, c. 407, s. 135; 1973, c. 1330, s. 33.)

City of Graham

Sec. 12-1. - Loitering on streets.

No persons shall habitually loaf or loiter on the streets, nor shall any persons congregate on the streets or sidewalks in such a way as to obstruct or interfere with the free passage into, out of or by any public, business or private property. It shall be the duty of any police officer who observes a violation of this section to warn the offender and upon his failure to heed the warning to arrest him.

Dear Chief Cole:

Greetings! Thank you for meeting with me on Tuesday, October 20° to begin working on the I Am Change March there in Graham on Saturday, October 31° . I also appreciate your patience since that time as I recover from outpatient surgery.

I have been able to do a bit of reflecting and, as I expressed to you and your team, I am concerned by the City's response to our requests for closuce of xx blocks of North Main St. to keep marchers safe, and permission to (as we did on July 11) place a stage with a public address system there on the Court Square. I hope that we can resolve these two key issues, as they are critical to the vision and expression of our demonstration.

I found your leadership to be very effective in our meeting while some of the other voices within your department were disparaging. I am also grateful for Captain Sykes' assistance with the Alamance County Shecriff department assisting us to sevene a permit to the courthouse grounds. However, hearing outright, "we are not closing downtown" from Lt. Flood signaled to me that the end goal of this process was j'ss designed to obstruct or at least, limit our march and rally. That intent was made clear by further dialoguse.

We have not asked the City to close downtown. We have petitioned to close the necessary portion of North Main Street and perhaps one lane of traffic on East Elm a block from Court Square to divert traffic from the North side of the courthous equare so that we can convene our march and rally, with stage, upon North Main street court square, between the hours of 8:30am and 2:30pm on Saturday, Oct. 31. This is essentially the same request we made and which was granted for the July 11 march and rally. This should have no significant impact on public access to the polling place at 201 W. Elm, which is a block away and accessible from Maple Street and the other cross streets.

With the announcement of members of George Floyd's family and renowned Attorney Benjamin Crump being a part of our march next weekend, we expect a large amount of people to join us on Saturday, and closing the north side of the circle is important to keep everyone safe. The significant number of marchers we anticipate is in large part because of the issues of white suspensancy, racially-biased policing, and racial oppression persist which persist in Alamance County. The niceties and pleasanties that we exchanged diving our walk from your office to the Sherriff's office, in addition to the cordialities that we have exchanged in the part have unfortunately not kept black people from being targeted, mistreated, brutalized, racially oppressed, falsely arrested, charged, imprisoned, shot

I am in receipt of your letter dated 10/26/2020 in response to my request for planning for 10/31/2020.

On 10/13/2020 you requested from the Graham City Council permission to host "I am Change March to the Polls" parade in the corporate city limits of Graham, NC. In your communication with the council you stated that you needed to utilize the roadway for a march expressing safety concerns with narrow sidewalks, and you also stated that the march would start at 11 a.m. and conclude at 2 pm. It is our understanding that your final destination will be the north steps of the historic courthouse for your permitted time for message sharing and topic presentation. During your communication, you did not disclose to the City Council that you wished to hold this event from 8:30 a.m. to 2:30 p.m. on 10/31/2020.

The Mayor and City Manager stated that you would need to coordinate this event with the police department. At our meeting on Tuesday 10/20/2020 we discussed five (5) different options to accomplish your mission and the public safety mission. It is my understanding that you have obtained a permit for the use of county property which will eliminate the need for staging in the roadway.

To facilitate your request, I have attached a visual illustration of a plan to coordinate this event. This will provide for the control and movement of pedestrian and vehicular traffic, including emergency services and will protect the safety of participants and of the general public. I will have the park closed for Graham Police Department use and parking spaces that are outlined in orange for pedestrian overflow. These will be the areas that will be dedicated for public safety use. After our conversations with you regarding the uncertainty as to the number of participants, I want to make sure we have adequate space for individuals to stand safely and not impede or block traffic.

Thank you, Chief Cole. Rev. Drumwright and I can get on a Zoom call Thursday at 1pm. It seems there are some issues to work out before another walk through the area would make sense.

One issue is whether you are denying his request to set the stage and PA up where it was on July 11: there at the junction of North Main and Court Square. If you are denying that request, then we are willing to set the stage up on the North landing in front of the north entrance steps to the courthouse. Please let us know.

Regarding the time referenced in Rev. Drumwright's letter, the 8:30am request (as was so on July 11) is just to set up the stage and PA before the march begins at 11:00am. There will not be a crowd of people there, and no need for police presence during that time—there will just be Rev Drumwright and his volunteers setting up the stage and PA. They will be taking the stage down and moving the PA system once the event is over, probably between 1:30 and 2pm.

As far as the route march, our understanding is that the City agreed to close Hwy 87 from Waymen's Chapel to the courthouse from 11:00am to 2:00pm. Please explain the statement in your 10/27 letter that you "do not feel it is necessary to close NC Hwy 87 to vehicular traffic."

It's also not clear to us what you are saying about the orange areas outlined on the map you attach to your letter. Are you saying you will not allow people to congregate anywhere else? Are you saying you will not agree to restrict vehicular traffic on the north side of the circle between uam and 2pm? Given the permitted area for this demonstration, the limited time frame Rev. Drumwright has requested that half of the circle be closed to vehicular traffic, and the number of people anticipated for this demonstration, we are concerned that you would consider not closing that portion of the circle to vehicular traffic, as that would certainly potentially jeopardize people's safety.

Thanks in advance for answering the above questions, and we are happy to discuss whatever else needs to be discussed on Thursday at 1:00pm.

Graham Police and Fire Departments overview of public safety plan during October 311° "I am Change March to the Polls" organized by Rev. Gregory Drumwright. The following points will detail the route for the march, location of the rally, dispersal point, prohibited activities, etc.

The following public safety plan will be utilized;

- Rev. Drumwright secured a permit for use of the Historic Courthouse grounds for the rally and presenters portion of the event scheduled 10/31/2020.
- Participants will gather at Wayman's Chapel AME Church located at 592 N. Main Street and the pedestrian parade will begin from that location.
- There is no street side parking at the church, therefore, the Graham Recreation
 Center parking lot is available for additional parking for participants. Officers will
 be present in this location to assist participants with parking once the church
 parking lot is full.
- Participants will march on the roadway of N. Main St. from the start location to the Historic Courthouse. Police will perform traffic control along the parade route in order to ensure a safe march/pedestrian parade.
- Police will temporarily control traffic on Court Square for the participants to safely
 cross the street onto the county courthouse property. Once there the road will be
 cleared and normal flow of traffic will resume.
- The Police Department has closed Sesquicentennial Square as well as the parking spaces and sidewalk on the northwest and northeast side of Court Square for overflow of pedestrians/participants that will not fit on the country property. The parking spaces surrounding the Historic Courthouse on the north side of the property will also be closed for the purpose of parade/pedestrians to observe guest speakers.

- If the event organizer has Bluetooth audio speakers that he would like to set within the park to allow for everyone to hear, that is permissible.
- Designate areas will be established for any counter demonstrators in the event such person should attend in order to keep person separate from the event participants that are located in the designated police areas.
- Once the rally portion of the event has concluded (2:30pm), participants will disperse and may
 move to the early voting site, located at the Alamance County Office Annex Building on 201
 W. Elm Street, at their discretion via city sidewalks.
- Police personnel will assist with ensuring that participants are able to safely cross the road and clear the area once the event has concluded at 2:30pm.
- The Graham Police Department and their partners will handle traffic control and public safety responsibilities for the duration of the event.
- Participants will not be allowed to walk/gather in any public street except for the area
 previously described in this document.
- Participants must also not interfere with the operation of businesses or private property in the city.

Chief Cole:

Thank for you for these details.

This plan does not include our necessity to build a stage so that ALL onlookers from other sides of the streets, while cars are moving, can witness our rally. In addition, we would require the use of our PA system. There is no such thing as a bluetooth audio system that will amplify sound for a public event of this size.

As requested all along, we need to build a stage for our rally, there between the monument and courthouse sidewalk.

Further, allowing cars to pass THROUGH THE RALLY, while it is in progress, is not only an attempt to disparage our event, the vehicular traffic quells the efforts of our rally and presents a massive public safety hazard for the large numbers of people we expect.

Your department well knows that counter protesters honk their horns while driving through the court square, when they see our presence, as a means to distract and distort our message. We have seen dozens of vehicles who do this routinely each and every weekend. With this knowledge, why would you create a situation for that to happen on Saturday? Is the GPD disinterested in our peaceful event being routinely disrupted?

We believe that closing one half of the traffic circle is not only the best solution, on the north side of the courthouse, is also the safest solution. As it stands, we are not in agreement with the plan you have presented.

I remain willing to meet with you tomorrow. I am able to do such between 8am-10am.



Mr. Drumwright,
In response to your request to assemble a stage at the Historic Courthouse, I met with Alamance County Attorney, Clyde Albright, this morning. He advised that a stage would be approved upon the north side landing. The stage cannot be between the sidewalk and the monument due to the location of the crosswalk. Per our facility use policy crosswalks must remain clear to wit:
Access to the sidewalk on the opposite side of the street must be maintained at all times during the event. Additionally, access to the Historic Courthouse must be via crosswalk and these crosswalks must remain clear. Blocking of traffic around the Courthouse Square is not permitted.
The area approved for your stage is the concrete portion of the north-side landing between the bottom of the north-side steps and the beginning of the sidewalk as indicated in yellow on the below graphic:
Keep in mind that there is a flagpole in the center of this area, along with a COVID screening structure near the handicapped ramp that will remain in place. Please come out to make a survey and measure the area before bringing a stage that is too large. You will not be allowed to erect a stage anywhere else on the property and you did not indicate that you would be setting up a stage on your application.
As it stands right now, the roofing company still has their equipment on the south landing and east landing of the courthouse property. With the rain today, I do not believe that they will be finished this week and so those areas will be closed for use.
Also please keep in mind that all sound equipment has to be battery powered as electricity is not provided and generators are not allowed on the property per our facility use policy:
Will sound amplification be used at the event? Yes \square No \square If yes, sound amplification must be battery powered. Electrical generators are no allowed on Historic Courthouse property.
Additionally the City of Graham has agreed to close all the parallel parking places around the Historic Courthouse. Pedestrian barricades will be in place to separate those parking areas from the roadway and those parking areas will be available for your use.
I hope this answers all your questions regarding use of county property.

Dear Mr. Ward (or whichever City Attorney is at this address):

I have dropped Chief Cole from this communication, although you have not ever communicated with me in lieu of allowing her to communicate with me directly concerning Rev. Drumwright's requests related to the "I am Change: March to the Polls" demonstration in Graham this Saturday. However, in light of Chief Cole's recent communications, I am concerned that we may be approaching a First Amendment unfettered discretion problem which, if not resolved soon, could lead to further litigation against the City. That is not the result we want, and hope that we can resolve this today.

The two issues to resolve, as I see them, are 1) Chief Cole's refusal to close the north side of Court Square rotary to traffic between 11:00 and 2:00pm on Oct 31; and 2) the City and County's response to the stage/PA issue. On the latter, Rev. Drumwright had always discussed with the City setting up the stage where he had it on July 11: where North Main meets Court Square, and using his generator to power his PA. Chief Cole said he couldn't do that, but she's given no reason why she's treating this request differently from how the City treated it on July 11. The County will let him set up on the North landing of the courthouse, but prohibits his using the generator, which means he can't use his PA. Issue (1) raises even more serious concerns, since it is clear that allowing traffic around the circle during this demonstration is likely to disrupt the demonstration significantly and also pose a significant public safety risk.

At Chief Cole's request for a meeting, I had proposed 2:00pm today for a Zoom call. Rev. Drumwright and I are available then, or we could do 2:30 or 3:00pm. Please advise if you and/or Chief Cole wish to conference with us at any of those times today, and I'll send around a link. Alternatively, we can make ourselves available tomorrow morning.

I have dropped Chief Cole from this communication, although you have not ever communicated with me in lieu of allowing her to communicate with me directly concerning Rev. Drumwright's requests related to the "I am Change: March to the Polls" demonstration in Graham this Saturday. However, in light of Chief Cole's recent communications, I am concerned that we may be approaching a First Amendment unfettered discretion problem which, if not resolved soon, could lead to further litigation against the City. That is not the result we want, and hope that we can resolve this today.

The two issues to resolve, as I see them, are 1) Chief Cole's refusal to close the north side of Court Square rotary to traffic between 11:00 and 2:00pm on Oct 31; and 2) the City and County's response to the stage/PA issue. On the latter, Rev. Drumwright had always discussed with the City setting up the stage where he had it on July 11: where North Main meets Court Square, and using his generator to power his PA. Chief Cole said he couldn't do that, but she's given no reason why she's treating this request differently from how the City treated it on July 11. The County will let him set up on the North landing of the courthouse, but prohibits his using the generator, which means he can't use his PA. Issue (1) raises even more serious concerns, since it is clear that allowing traffic around the circle during this demonstration is likely to disrupt the demonstration significantly and also pose a significant public safety risk.

At Chief Cole's request for a meeting, I had proposed 2:00pm today for a Zoom call. Rev. Drumwright and I are available then, or we could do 2:30 or 3:00pm. Please advise if you and/or Chief Cole wish to conference with us at any of those times today, and I'll send around a link. Alternatively, we can make ourselves available tomorrow morning.

Mrs. Haddix,

The road closure is only temporary to accommodate the march until it reaches the final destination, which I though was the historic court house. Once the group arrives Main st. will be opened back up for normal traffic. Mr. Drumwright will not be allowed to block N. Main St. at courtsquare and no road closures are permitted. The lack of communication from Mr. Drumwright since our first meeting has left us scrambling at the last minute to arrange for a safe event for Mr. Drumwright's group. Street closures of the type that Mr. Drumwright is requesting requires city council approval and must be heard during a scheduled city council meeting. This rule applies to any group that requests a road closure, not just his. As I said this morning Mr. Drumwright missed the deadline to get his request on the agenda for the council to hear. I was hoping to have an open line of communication to ensure a safe event and am disappointed that this event will be a point of contention between our agency and Mr. Drumwright's group. To accommodate his speakers he is permitted to set up his trailer and pa system in The northwest corner of sesquicentennial square park in the closed off section and have his presenters address the crowd from there. I reiterate that he will not be permitted to block N. Main St. at historic courthouse.

Frank:

Chief Cole has already agreed and planned for closure of North Main from Weyman's Chapel to the Historic Courthouse as stated in the attached document. It is also worth noting that she did not mention any of the reasons you cite for refusing to close the north half of the Court Square rotary and for not allowing Rev. Drumwright to set up his stage on North Main. Neither you nor anyone else representing the City mentioned any of these concerns during the City Council meeting discussion of this event on October 13. The City's refusal to close that portion of the circle for 2 hours to allow this permitted event to happen safely is especially troubling given the county's approval of the permit for use of Courthouse Square, the limited time of the closure request, and the easy alternative available access in and around downtown for residents, voters, and emergency vehicles. This situation illustrates the dangers of having a process for permitting that is not transparent and allows for unfettered law enforcement discretion. Chief Cole suggested on our call today that Rev. Drumwright set up his PA system in either the park or other corner of North Main and Court Square, so this is now the plan: he will station a truck and short trailed with his generator and PA on one of those corners, and pull it out into North Main at 11:00am (since the street will otherwise be closed to vehicular traffic at that time). That will serve as a stage and will also serve to protect rally participants who are standing in North Main St. from the vehicular traffic that the City is apparently continuing to allow around the circle during this permitted event. March and rally participants will, as Chief Cole also suggested, congregate in all areas outlined in orange on the map she attached to her Oct 27 letter (both corners, and northeast and northwest Courthouse lawns and sidewalks, North landing and steps) and will also (if their numbers require) occupy that portion of North Main closest to the courthouse.

Elizabeth:

I'm sorry I was unable to join the call this morning. I hope you can appreciate that the City has a delicate balancing act specific to this event. Public safety concerns are always the foremost consideration we have. Our staff, in conjunction with our partnering agencies, have identified the potential public safety risks and are making the necessary arrangements to minimize the same. Based on the attendee information provided by Mr. Drumright, a determination was made that a street closure is not required as a public safety measure. In this case, unnecessary closure of the subject streets causes 1st responders to take alternative routes to the densely populated northern part of the City, adding to general public safety concerns. As you know, in certain emergency situations every second matters and alternative routes are not the primary routes for a reason. Also, if roads are closed it further compromises the ability of our first responders as they (and their vehicles) become traffic control attendants rather than focusing on their primary public safety duties. This also affects staffing and the allocation of resources already in place.

In addition to ensuring public safety, closure of streets is further complicated by the fact that the one stop voting poll is only about 500' away from the Historic Court House. Closure of the northern half of court square in effect forces limited access to the 100 Block of N. Main Street and the 100 blocks of Elm St. (and a one way condition). This would then put the impact within a matter of feet from the poll. Everyone on this email knows the added layer of law surrounding elections and the City does not want restrict anyone's access to the polls.

I understand that we are in the $11^{\rm th}$ hour of preparations for the event and I respectfully request that all participants defer to the best judgement of law enforcement to ensure the safety required of all involved. If you have further questions, please direct them to Chief Cole. Thank you in advance for your cooperation.

Mr. Maness,

I've just left a voicemail message for Bryan Coleman and copy him here as well. On our call earlier today with Chief Cole, I asked if there were any public safety or other reason that she has not agreed to close the NE – NW Court Square (also called NC HWY 87) from 11:00am to 2:00pm or allow a stage with a generator-powered PA system at the juncture of North Main and North Court Square tomorrow and she said that she was not authorized by the City Council to do either of those things. She said only that Rev. Drumwright did not specifically request those two items on Oct. 13 when he addressed City Council. We all agreed that, after listening to the recording of that portion of the Oct 13 City Council meeting, I would contact you and Mr. Coleman for guidance.

During the limited (3 minutes) that Rev. Coleman was permitted to make his request on Oct 13, he did refer several times to his July 11 march and rally, which involved GPD closing a larger stretch of North Main / Hwy 87 than is sought for tomorrow, and also involved setting up a stage and PA at the same location he's seeking to use now, for approximately the same period of time. On Oct 13, you and Mr. Coleman were both very clear that the City Council would take "no action at all" (Mr. Coleman's words) on Rev. Drumwright's request, since with the repeal of the permit and parade ordinance back in July, there are "no rules now" (your words). You both directed Rev. Drumwright to coordinate all logistics for the Oct 31 march and rally with Chief Cole, which he then proceeded to do. Chief Cole has been aware of these two requests at least since October 20, when she met in person with Rev. Drumwright and discussed the stage, PA and closure of the NW-NE Court Square. She has not provided any reason, other than "lacking authorization" from the City, for denying those requests or otherwise treating Rev. Drumwright and this march and rally differently than his July 11 march and rally (which was also coordinated with the City and ACSO), and has now told us to seek that authorization from you.

Please advise as soon as you can whether the City Council must authorize Chief Cole to allow the stage and road closure specifically. We are aware of no policy, rule or statute that would require that. As I told Mr. Coleman in my message to him, I am happy to talk with him and/or you by phone, at 919-548-3584.

PS. The County's offer to let Rev. Drumwright put the stage on the North landing unfortunately does not solve the problem because the Facility Use Policy prohibits use of any sound amplification on courthouse property that is not battery powered, and no such

system will be sufficiently heard by the number of participants Rev. Drumwright is expecting (at least the same number as were present on July 11, which was around 1,200).

Understood. Rev. Drumwright will set his PA and platform up at Sesquintennial Square. He will be speaking to the rally participants who hopefully will all be able to stand at safe distances from one another on the courthouse steps, landings, lawns and sidewalks. As you know, those areas are all reserved for exclusive use between 11-2pm for participants in this event who support The message of this event. Therefore, we expect GPD and ACSO to intervene if necessary to remove counter demonstrators (which will include folks with Confederate and other similar symbols) from the permitted area during that time. Counter demonstrators may be within ear range, but at a far enough distance so that they do not interfere with or obstruct Rev. Drumwright's message or the message of any other speakers he has at this event.

Which also means that if there is traffic around that circle interfering with the message, either with shouting or flags or other disruptive activities (which presumably may also be a traffic violation), we expect GPD to do something about that.
