#### GRAHAM RECREATION AND PARKS COMMISSION SEPTEMBER 14, 2022 APOLLO FIELD

#### **MINUTES**

PRESENT: Chair Jay Cook, Brian Cutlip, Laurie Pickard, Nicki Smith, Tim Beshel STAFF: Brian Faucette

Prior to the meeting, the Recreation Commission visited the Graham Civic Center to view the roof/ceiling damage, the samples for the new flooring and the newly renovated sand volleyball court.

Chair Cook called the meeting to order at 6:55 with a welcome.

#### **MINUTES**

-Mr. Cutlip made a motion to approve the minutes of the August 10, 2022 meeting. The motion was seconded by Mrs. Smith and unanimously approved.

#### **CHAIR'S REPORT**

-Chair Cook reported the Friends Group agreed to accept the donation of \$1,000 given for the renovation of the interior of the pontoon boat at Graham-Mebane Lake used for lake cruises.

-Chair Cook asked Mr. Faucette to thank Tel Fehlhafer and his staff for their hard work on making the athletic fields look great.

#### **DIRECTOR'S REPORT**

-Mr. Faucette did not offer a Director's Report at this meeting in order to allow for a timely meeting after the Civic Center visit.

#### **OLD BUSINESS**

- -Mr. Faucette reported City Administration recently completed a similar tour of the lake as the Commission did in Aug. Staff's concerns of trespassing and removal of vegetation by adjacent land owners was relayed during the tour. To address these concerns, Mr. Faucette asked the Commission for direction on action to be taken in the future. The Commission asked GRPD staff to consider the following:
  - 1) send a letter to all adjacent land owners surrounding Graham-Mebane Lake with state regulations attached
  - 2) encourage a phone call between the City Managers of Graham and Mebane to directly discuss the issues
  - 3) educate the County Planning Department on the regulations governing the lake and encourage the Dept. to educate developers, real estate agents and land owners
  - 4) invite adjacent land owners on a pontoon boat cruise around the lake to see firsthand the effects of vegetation removal

#### **NEW BUSINESS**

- -Mr. Faucette updated the Commission on the anticipated timeline for the Rec. Center Gym Floor Replacement (mid-October) and the Rec. Center Gym Repainting (Oct. 3<sup>rd</sup>). A new sound system was recently installed in both gyms at the Rec. Center. The new system is Bluetooth capable and can be used for various functions and activities.
- -Mr. Faucette informed the Commission the City Council approved the use of ARPA funds to complete the roof repairs and installation of a new floor at the Civic Center. The roof work should begin the week of Sept. 26<sup>th</sup>. The floor replacement is scheduled to begin the week of Oct. 17<sup>th</sup>.
- -Mr. Faucette has requested a referral for an HVAC company that holds the appropriate license to install a new HVAC unit at the Rec. Center.

**Parks:** City Council approved the installation of cameras to monitor the entrances of parks across the City. IT will work to complete this project.

Commission members were informed the GRPD maintains and prepares the facilities for ABSS and GRPD practices and games. If an exception needs to be made, both parties are expected to communicate and agree to the adjusted timeline. Contracts formalizing the relationship are set to expire in 2024. Commission members encouraged Mr. Faucette to begin reviewing the contracts now ahead of the 2024 expiration.

With all business concluded, Chair Cook made a motion to adjourn at 8:05pm, seconded by Mr. Cutlip and unanimously approved.

# **Graham-Mebane Lake End-of-Year Report Graham Recreation and Parks Department**


## Warden's Summary of 2022

The lake had a good year. Public use, measured by visitation and boat launches, continued to drop from the Covid highs of 2020, but remained above the "normal" (pre-Covid) levels. Fishing was above average for the main sought-after species and we continue to see an increase in non-traditional lake users. Increasingly, people are discovering the lake and find

that there is something for them here.

The lake was 10% less "busy"
than last year; though with a new
program and changes to our fee
structure our revenue remained the
same. Our top revenue sources are
Motorized Boat Launches, Bank Fishing,
Vessel Rentals, and our Fishing
Tournaments.

Revenue remained way above average (up 30% or \$14,000). The User Fee changes resulted in an increase of



\$3,300 and almost no pushback from customers. A concern is that bank angling took a 25% drop. With no complaints from bank anglers it is difficult to determine the cause.

#### A few points on fishing and fish habitat:

- We weighed-in 19 Trophy Bass (over seven pounds); that's half of 2020 but still a respectable number for a lake our size. Few anglers bring up crappie and catfish for weighing.
- Fishing pressure (by number of boat launches) reduced to just above normal.
- The bass fishery remains healthy and robust. The bass remain "fat" and we have not seen stress sores or unhealthy bass. A healthy and numerous shad population (bass food) is one reason why.

- Through our partnership with NC Wildlife and our Regional Fisheries Biologist we received an assortment of fish habitat structures, had a dozen trees cut and dropped into the lake to provide fish habitat, and began planning a habitat revegetation project.
- We did experience low water levels in the fall, which affected fishing success.

In addition to the Lake Warden's 2,080 full-time hours worked, the Assistant Lake Wardens logged 1,450 hours, and Lake Attendants 2,850 hours, for a total of 6,400 hours worked. This falls right in the middle of range for the last three years. The Lake was open about 2,700 hours (230 days) this year.

## 2022 Programs and Events at Graham-Mebane Lake

We re-worked our **Big Bass Tournament** (BBT) a bit this year to increase interest and help bring it to revenue neutral or into the black. We lowered the monthly winners to seven and added the Second Chance Tournament, a sort of tournament within a tournament (more on that below). Our entrants rose to 70 and our administration percentage to \$437, but the \$650 in prizes (Annual Permits and fishing swag) kept us in the red. We'd need 90 entrants to cover the Annual Permits. Interest though, remains high. A common question we receive is 'what's on the board?' i.e. what's the weight of the leading bass? We'll keep tweaking this event, though this year's changes have helped.

In the Second Chance Tournament, a part of the BBT, we keep track of entrant's heaviest bass caught throughout the year. The Top 8 leaders (who do not win a month) get their own tournament in early October. This tournament winner then gets the chance to compete in the BBT Fish-Off for the prize money. The goals of this tournament are to provide a second path into the BBT Fish-Off for those who are never quite able win a month (which hopefully raises interest in the BBT) and to generate revenue to help cover BBT costs.



Two-thirds of the BBT entrants entered Second Chance. Interest waned over the heat of the summer, but really began to pickup the last six weeks of the tournament with entrants

vying for that number 8 spot. We think that the late interest and seeing how Second Chance operated will increase entrants next year. We sourced some donated fishing tackle to give to the Top 8 as door prizes — enough to cover their entry fee.

Second Chance brought in \$470. When combined with entry fees from the BBT and G-M Lake Bass Tournament (below), the BBT finally moved in to the black, plus we were able to provide another tournament for our customers.

Our **Graham-Mebane Lake Bass Tournament** (still haven't found a shorter, catchier name) was held in late March. Its objective is to provide a tournament experience for anglers who are not bass fishing club members and to bring in revenue to cover the BBT losses. We had 19 boats this year and a prize total of \$1,425. The Lake's Admin fee was \$475. The tournament ran very well — no ties this year!



The Lake held four evening **Catfish Tournaments** this summer. We averaged 58 entrants per tournament (wet weather knocked one way down) which is a bit lower than the last two seasons, but still a good turnout. These tournaments remain quite popular for families as well as the more hard-core anglers. Labor costs were \$240/tournament, while our revenue was \$310; keeping the program profitable for the third year in a row. We've shortened the sign-up process about as much as we

can and don't expect many changes for the upcoming year.

The **Youth Fishing Day** is a free fishing event for kids ages 4 to 15. Attendance was about 60 this year, down a bit from previous years. The assistance of the Programs Division on this program is much appreciated.

This year, we may have made a mistake by moving **Family Day at the Lake** to a week later in June. Attendance was half of the previous year (weather was not a factor). We still had a great time and the 50 or so attendees spent more time on the water, playing games, and enjoying a SnoBall than previously. We'll move back to the first Saturday in June this coming year. A big thank you goes out to Brandy and Emma for making this a great event.

We tried something different for Alamance Creek Week this year. Instead of hosting a Family Fishing Clinic, we put our heads together with Stormwater Smart (the Creek Week sponsors) and decided to hold a Kayak Lake Clean-Up event. Participants could bring their own kayaks or use some of ours and spend a few hours on the water picking up trash and debris. We had fewer participants then desired, but Fox News 2 came out and did a segment on it.

Our Vessel Rental Program continues to grow. This year the 7-year program moved completely into the black. Jonboats are becoming quite

popular, accounting for nearly 40% of all rentals this year. To accommodate this increase, we are researching ways to re-configure our dock space and make the launching of jonboats easier.



Kayaking is one boating activity that has not slumped after Covid or been reduced by fuel costs. Our numbers - we launched 780 customers on **Non-motorized Boats** this year, bringing in \$4,371 – have stayed steady since 2020. The kayak launch ramp is holding up well and we expect it will have payed for itself by the end of next year.

The changes to our **Annual User Fee Permit** this year (removing the Out-of-County permit, adding Non-Motorized Boat and Bank Fishing options, and changing to a full 365-day term versus the remainder of the fishing season) have been well received by our customers. We sold 50% more permits than last year - a whopping 195 permits (148 motorized, 30 non-motorized, and 17 bank fishing). They were used over 2,000 times. Seventy purchasers used their permit enough times to pay for itself. Five purchasers used theirs over 50 times (the most used was 101 times), and the average use was 7 times.

Lake Cruises are the newest addition to the lake offerings. Using the pontoon boat gifted to us by the City of Mebane, we offered two seasons of lake tours: a Summer season in July and a Fall season from mid-October through early November. We ran 27 cruises, taking 215 customers out for a 45-minute cruise of the lake. The program has been well received and we have plans to expand it in 2023.

We had to purchase some personal flotation devices and a few other supplies costing \$1,200, but revenue was almost \$1,900, so we ended the year \$700 to the good. Additionally, the Lake received a \$1,000 donation to help fix up the boat. We have already begun the 'fixing up' process by removing dilapidated equipment and sourcing new flooring and seating.


Graham-Mebane Lake participates in the NC Wildlife Resources Commission's Community Fishing Program. The Commission provides four solar-powered fish feeders to attract fish to the bank fishing area. The Lake purchases the fish food and maintains the feeders. The lake also participates in the Commission's Tackle Loaner Program. Children ages 6 to 12 may borrow a rod and reel while they fish at the lake.


**Fishing clubs** hold day tournaments at the Lake in spring and fall. We had seven tournaments in 2022, totaling 75 boats. Due to parking issues, we restrict the number of tournament boats to 20 per day. Clubs must schedule their tournaments and pay our normal user fees. Tournaments are not held in June, July, and August to prevent fish loss in live wells.


Boat launches are returning to pre-Covid levels. A reduction in big bass catching and increased fuel costs are factors, though the overall lake trend is still an increase of about 100 boat launches per year.






Lake visits continue their slow drop from Covid levels. Increases in vessel rental and program/event attendance mask the boater and bank angler reduction. Our trend line indicates an increase of 550 visitors a year.

Despite a reduction in numbers of boat launches and bank fishing visits, our revenue stayed the same as last year. The new user fee plan, an increase in vessel rentals, and new lake cruise program are the main drivers. We have seen a 75% increase over ten years ago.






Customers responded positively to the Annual Permit changes. We sold 141 Motorized Boat, 30 Non-motorized Boat, 17 Bank Fishing, and gave eight Permits as BBT prizes. Forty-eight permits were for Senior Citizens or Person with a Disabilities. Crunching our POS numbers gives us insight to who our customers are and possible trends, e.g. annual permit launches made up half of all motorized boat launches.




