#### **MINUTES**

-Mr. Cutlip made a motion to approve the minutes of the September 11, 2024 meeting. The motion was seconded by Mr. Burnette and unanimously approved.

#### **CHAIR'S REPORT**

-Chair Cook did not have a report this month.

#### **DIRECTOR'S REPORT**

-Mr. Faucette reminded the Commission of the City Christmas Lunch on Dec. 11 @ 11:30 at Trailhead Church.

-Mr. Faucette reviewed the City Manager's budget timeline and asked Commission members to submit facility improvements and program ideas to be included in the budget request.

-Mr. Faucette updated facility repairs at the Historical Museum (windows have been replaced) and Maple St. Center (floors to be replaced in early Dec.).

-Mr. Faucette informed the Commission that City Council accepted a gift of a kaleidoscope sculpture to be placed at Graham Regional Park.

#### **OLD BUSINESS**

- -Mr. Faucette updated the Commission on several actions taken by City Council at the Nov. 12<sup>th</sup> meeting:
  - 1. Land Acquisition: Teer Property Council approved a budget amendment to fund the purchase of property adjacent to Cooke Park owned by the Teer Family.
  - 2. Accessible Parks Grant Council approved a budget amendment to fund the required local match.
  - 3. Graham Regional Park Master Plan Council selected WithersRavenel to complete the Master Plan.
- -Mr. Faucette reported there are no updates on the Stewart Property (Graham Regional Park) but hopes to revisit the project during the Graham Regional Park Master Plan process.

#### **NEW BUSINESS**

- -Mr. Faucette updated the Commission on several projects at Graham-Mebane Lake:
  - 1. The ramp replacement project start date has been delayed by the NC Wildlife Resources Commission to late April-early May.
  - 2. A design plan for slips docks with a roof was presented
  - 3. The family involved in a trespassing issue discovered this spring has met with GRPD staff to work out an agreement to restore the bank.

    - Now that most FT employees with GFP are CPSTs, I would like to add car seat checks as a service during First Responder Fridays. This will be beneficial to do while in neighborhoods as many people aren't aware of this necessary service that we offer.

#### Winter Programs

Basketball season is fully underway as we're into the games portion of the season! We've had some intriguing games already this season with multiple games ending in buzzer-beaters or game winning shots. The most competitive age division so far has been 10U boys which has 3 teams at the top that're a step above the rest. The other 4 teams are pretty even and all have the ability to win multiple games this season.

This season we'll be partnering with Gibsonville and Green Level in some age divisions. With the increase in numbers our goal is to play everything in-house but some age divisions we still combine with other departments to help form a full league. Originally, we planned to play with Green Level and Gibsonville in the 6U age division but due to headaches in schedule making we backed out at are going inhouse for 6U.

We've made a couple of rule changes for the season that will be in effect for our inhouse leagues and the 5U age division. In our in-house leagues that keep score (8U and above) we're putting in a "mercy rule". This rule will require a team's top two scorers to sit on the bench if their team is up by 15 or more in the 4th Quarter. If a lead of 14 or less is restored then the two players may re-enter the game; once the score goes back to 15+ they're required to sit again. So far, the rule has been effective and helped reduce the number of "blow-outs". We're seeing that when teams sit their top scorers the games become more even and in most cases the leads reduce to inside 10 points.

In the 5U age division the rule change revolves around the beginning of games. Each game will begin with free-throws attempted by each player. This will give every player a chance to shoot the ball!

- o 14U: 21 participants (2 teams) (1 on wait-list)

#### **Upcoming Spring Programs**

Registration for soccer and lacrosse opened on December 1<sup>st</sup> and will run through February 1<sup>st</sup>. Registration for baseball, softball, and t-ball will open on January 1<sup>st</sup>. Adult Pickleball will be returning for the Spring with us expanding from 2 divisions to 3! We have opened registration for returning teams, they had until December 31<sup>st</sup> to inform me if they're playing in the Spring. If I don't hear back their spot will become open to the public when public registration opens on January 1<sup>st</sup>.

Soccer registration was slower than I hoped for through January but hopefully it'll pick up as we turn the calendar to 2025.

#### Spring Soccer Registration Numbers

- o 5U: 5 players
- o 6U: 13 players
- o 8U: 15 players
- o 10U:17 players
- o 14U: 16 players

Thus far I've had 10 of the 16 pickleball teams confirm they're returning. This leaves 14 spots open for new teams.

Lacrosse currently has 3 players registered. We'll be shooting for double digits so that we'd be able to have a program.


#### **Fall Sport Surveys**



What athletic program(s) would you like to see added in the future? 10 responses




On a scale of 1-5, how would you rate your overall experience with the sport? 10 responses




#### Did you enjoy the program?




Fall Soccer (38 Responses)


On a scale of 1-5, how would you rate the participants overall experience with the sport? 38 responses



What athletic program(s) would you like to see added in the future? 38 responses




Did the participant enjoy the program? 38 responses




Flag Football (13 Responses)

# **Graham-Mebane Lake End-of-Year Report Graham Recreation and Parks Department**


#### Warden's Summary of 2024

The lake had another good year in 2024. Public use, measured by visitation and boat launches, remains at a high level. Fishing was above average for the main sought-after species and we continue to see an increase in non-traditional lake users.

We did the paperwork for the needed infrastructure improvements in the Fall. New launch ramps and docks, and a slip dock are expected to be constructed in Summer/Fall of 2025.

The lake hit a new high in revenue this year, but just barely - a 2% increase over 2023. Vessel rentals and bank fishing were up but all other sources were the same as last year.

Bass fishing remains very good at the lake, but crappie and catfish fishing are average.

#### Other 2024 Highlights:

- NC Wildlife fisheries biologists performed largemouth bass surveys in April. We won't get a
  written report as in past years, but the biologist said we have a great fishery, one of the
  best in the region. I'll post more information as it becomes available.
- We weighed-in 19 Trophy Bass (over seven pounds); a very good number for a lake our size. Few anglers bring up crappie and catfish for weighing.
- Fishing pressure (by number of boat launches) has remained steady over the last 4 years.
- The lake water level stayed at full pool all year except for a few weeks in July where it dropped a foot.

In addition to the Lake Warden's 2,080 full-time hours worked, the Assistant Lake Wardens logged 1,000 hours, and Lake Attendants 3,100 hours, for a total of 6,200 hours worked. Lake Attendants working vessel rentals or paddle programs worked 360 hours. The Lake was open 231 days (~2,700 hours) this year.

## 2024 Programs and Events at Graham-Mebane Lake

Our **Big Bass Tournament** (BBT) remains our premier event. The number of entrants (67) has remained steady as does the interest. Eight anglers competed in the Fish-Off in October with three of them splitting the \$1,250 prize money. All eight also receive an Annual Permit for the next year, which usually puts us in the red. But we address that in the next few paragraphs.

In the **Second Chance Tournament**, a subset of the BBT, we keep track of entrant's heaviest bass caught throughout the year that does not win a BBT month. The Top 8 leaders get their own tournament in early October. That tournament winner gets the chance to compete in the BBT Fish-Off for the prize money. The goals of this tournament are to provide a second path into the BBT Fish-Off for those who never win a month, raise interest in the BBT, and to generate revenue to help cover BBT costs.

Three-fourths of the BBT entrants entered Second Chance. Lake Staff donated new fishing tackle to give to the Top 8 as prizes – valued enough to cover their entry fee.

Second Chance netted \$490. Combining that with the BBT entry fees moved the BBT into the black. Of note, this year's Second Chance winner also won the BBT Fish-Off.

This is the second year of a partnership with the NC Wildlife Resources Commission on a Five-Year Habitat Enhancement Program. The objectives of this program are to enhance habitat for the fisheries of the lake, improve angler satisfaction, and stimulate the public to participate in habitat improvement projects. An additional objective (from my point of view) is to initiate a shoreline stabilization program that will decrease shoreline erosion and the resultant muddy water and lake sedimentation.



This year another 21 plant enclosures were built and over 2,400 native plants were planted. Of these, 400 went into enclosures and 2,000 planted strategically around the lake. On our September survey, we found the planted enclosures are doing well, but the individual plants are not. Deer ate many of them and others did not get established. We meet with NC Wildlife in February to plan next year's plantings.

Our single-day **Graham-Mebane Lake Bass Tournament** is held on the last Saturday in March. Its objectives are to provide a tournament experience for anglers who usually are unable to fish in one, and to bring in revenue to cover the BBT costs. We had 20 boats this year and a prize total of \$1,500. The Lake's Admin fee was \$500.





The Lake held four evening **Catfish Tournaments** this summer. We averaged 64 entrants per tournament, which is a perfect amount for our fishing area and resources. These tournaments remain quite popular for families as well as the more hard-core anglers. Labor costs were \$225 while our total revenue was \$525; keeping the program profitable for the fifth year in a row.

The **Youth Fishing Day** is a free fishing event for kids ages 4 to 15. Its goal is to interest youth (and parents) in fishing. We give t-shirts, a SnoBall, and a fishing-oriented goody bag to the attendees and raffle off 15 fishing rods. Attendance was over 100. The assistance of the Marketing and Programs Divisions (Brandy and Emma) on this program is much appreciated.

For the past few years, we have blended **Alamance Creek Week** into our Youth Fishing Day event. Danica Heflin, the Environmental Programs Coordinator for Stormwater SMART, talked with participants about how water quality affects the animals that live in it. Hands-on with the turtles (gently) was a huge success.

Our Vessel Rental Program continues to grow. We rented about 20% more vessels than last year. This is the second year with having two lake attendants working weekend rentals and it is working as hoped. Vessels stayed cleaner and were put back in service quicker after needing repairs.

Vessel tie-up and dock space was again an issue, but we did receive the CIP funding for a slip dock this year, and it is scheduled for installation next Summer.

Kayak rentals surged a bit to tie jonboats in numbers rented, but we were down to three jonboats for most of the summer as one was in the shop with a leaky bottom. Canoe rentals doubled over last year (23 to 53) and we are unsure why.

In our **Paddle Program**, we led eleven Paddle Tours of the lake and taught an Introduction to Paddling class. We had thirty-two customers and though we ended \$240 in the red, we continue to gain program knowledge and are looking forward to applying it next year.

We started our **Lake Cruises** in September this year. We ran 18 cruises, taking 111 customers out for 45-minute tours of the lake. We received many positive comments on the cruises and Steve had a blast piloting them. An issue did arise with the boat motor not switching into reverse gear — the gears would not line up correctly. We had a gear replacement kit installed, but it did not fix the situation. Turns out Mercury was aware of this problem and only used this gearing for one year; they have no fix for it.

Graham-Mebane Lake participates in the NC Wildlife Resources Commission's Community Fishing Program. The Commission provides four solar-powered fish feeders to attract fish to the bank fishing area. The Lake purchases the fish food and maintains the feeders. We also participate in the Commission's Tackle Loaner Program. Beginning anglers of all ages may borrow a rod and reel while they fish at the lake.

Fishing clubs hold day tournaments at the Lake in spring and fall. We had sixteen tournaments in 2024, totaling 184 boats. Nine of those tournaments had a winning bag (total weight of 5 bass) of over 20 pounds — a very nice metric for us. Due to parking issues, we restrict the number of tournament boats to 20 per day. Clubs must schedule their tournaments and pay our normal user fees. Tournaments are not held in June, July, and August to prevent fish loss in live wells.


The Lake has partnered with several local entities as an Emergency Training location. The Dive Team from the Alamance Co. Rescue Unit and the Alamance Co. Emergency Management agency use the lake for realistic, hands-on training. Most of these training sessions occur when we are closed, but for the most realistic experience for them, our


customers, and lake staff, we occasionally allow them to train on weekends – lake staff and our customers need to be able to adapt when actual emergencies occur.

Boat launches, visitation, and revenue are the three metrics we use to check growth and see how "busy" we are.


Boat launches were down 300 from last year, but the trend continues to be about 100 more launches a year since 2008.





Lake visits increased over last year, up 574 visitors. Bank anglers, vessel renters, and passive visitors led the increase. We continue the growth rate of over 500 visitors per year since 2008.

Lake **Revenue** peaked again this year, though it was a modest \$1,800. This increase was in vessel rentals and bank fishing, all others stayed relatively the same.






